The Little Center that Could!







Twenty-three counties in California applied for funding from the California Family Justice Initiative (CFJI) to start centers. Shasta selected as one of five sites in California.

What We Learned

Victims in our community told us they wanted civil legal services, counseling, protection orders, advocacy services, financial assistance, a safe place to bring their children and they don't want to travel all over town to get it.





What We Learned

You don't need a building – Just do it!

Crime Victims Assistance started co-locating services in their offices two days a week.

- Legal services
- Counseling
- Chaplin services

On site they already had sheriff deputies, prosecutors, investigators and more...





What We Learned

It doesn't matter how many agencies you have on board or what type of building you are in when you start to offer co-located services.

What matters is that you are doing it!

What matters is that victims have a safe location where people are working together to offer assistance.





Strategic Plan

The initial strategic plan took the center up to the point of hiring an Executive Director.

The Governance Team
Hired Michael Burke on
August 1, 2010.





“Lets just do it!”

Michael started on August 1st and got the keys to the building the same day.

Later that week the District Attorney said,
“Lets plan our grand opening for
September 1, 2010.”

About three weeks away.





Key to Success

A turn key building.

The planning committee for the center searched all over our small town for the right center. A place that needed very little work, was priced right and had a great location.





Shasta Family Justice Center

- Smallest and most rural center in the CFJI
- Least funded center
- Smallest staff
- First to hold grand opening
- 400 people attended





How did we do it?

We operated on cellular phones and the nearby restaurant's Wi-Fi (we got about half a good signal from the office) for the first three weeks.

We got our phone lines before our phone system so we ran to the closet for about about three weeks each time we hear the old bell phones from my attic ring.

What did it look like

Security System

\$14.99 Buzzer from Harbor Freight Tools

Each time someone exits our elevator they break the field of this sensor and a buzzer goes off at the front desk. We can run from anywhere in the center if we need to before a guest arrives.





What did it look like

Security System

\$399.99 Camera System from Costco.com to monitor the center

We called West Coast Data in Redding...They pull cable for all types of technology. I told him what we did and what we needed. I asked the cost. "I admire what you are doing and we are just happy to help."





Technology

- **Tech Soup & the Development Group –**
For \$1,000 we got \$8,000 worth of internet technology and they installed it for free.
- We now have 10 different LANs for our partners so they each have a secured network in the center. All networks are tied to our shared printer that was donated by Carols Office Systems (we only pay \$0.015 per copy)
- **Cisco & Development Group – For \$5,000**
we got our phone system that will grow with us.
- The Development Group secured us a grant so we received 40% off the system.



Center's Governance Structure

- The Center was founded with a Governance Team made up of partner agency's.
- The Child Abuse Prevention Coordinating Council acted as the funding agent.
- In March of 2011 all of the operations transferred to CAPCC.
- The Governance Team acts in an advisory role
- In May of 2011 the SFJC will file for a 501c3

Our Funding

- The SFJC operates on grants, sponsorships and donations. At this point the SFJC receives no public funding. (*We are one of the only FJC's not to receive this type of support. – We do have a large amount of in-kind support from public agency's*).
- We ask that if people give to our partner agencies that they don't stop donating to them in order to give to us. We would ask that any giving be above that amount.
- Because of our unique set up, the SFJC can operate (once under our own 501c3) for approximately \$150,000 per year. This includes salary of one employee, rent, insurances and supplies.








What is the Need?

- More than 200 calls for service to law enforcement each month related to Family violence – only 25% report




In 2009, 28.7% of Shasta County residents age 18-65 reported that they had experienced physical violence by an intimate partner compared to 14.8% of statewide residents of the same age.





What is the Need?

In 2009 Shasta County had 111 incidents of Rape or Attempted Rape. Much higher than state average.





Type of Substantiated Child Abuse/Neglect Allegations, Shasta County – 2009










What we did right

- Adopted a “Lets get it done” attitude early
- Strong Volunteers
- Media Relations – Average 1 to 3 stories a month since opening.
- Dedicated Partners
- Clear Focus
- Victim Centered
- Engage Community (trainings, access to facility, ownership, location, welcoming)





What we did right

- Celebrate success
- Acknowledge those who help
- Not getting discouraged
- Asked for help when it is needed
- Revisit – readjust – be flexible
- Strong alliances
- Never say never
- A home environment





Learn from our mistakes

- Set realistic goals
- Clear communications
- Don't personalize growing pains
- Understand Governance Structure
- Have funding matrix in place – Public, private, fundraisers, donations, etc...
- Follow up phone calls
- Perform exit interviews
